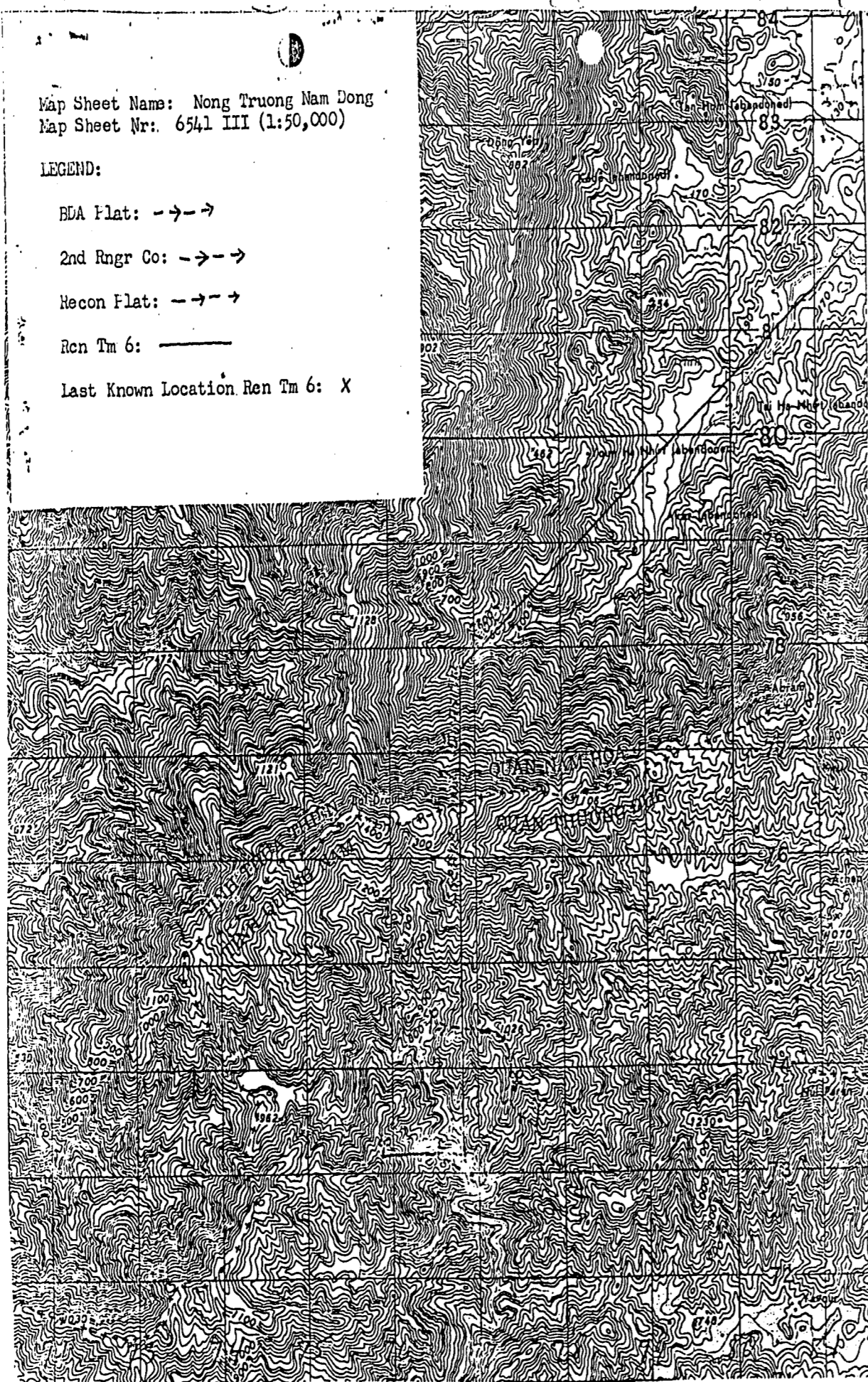

When the patrol saw that they were out numbered and had poor chances of getting out without help, they radioed for help. Before help got there the patrol had disappeared and could not be contacted by radio transmissions from circling aircraft. Aircraft continued to search the area where the patrol was last known to be, but met with negative results.</p> <p>Source knew of no one else in the Nha Trang, Republic of Vietnam area with knowledge of SUBJECT.</p> <p>AGENTS NOTES: An attempt to obtain samples of SUBJECT'S handwriting and photograph met with negative results.</p>
